1. *Bhimad Municipality* invites electronic bids from Nepalese eligible bidders for the construction of “*Chihandada Mohariya Siddhagufa Sadak*” under National Competitive Bidding procedures. The estimated amount for the works is NRs. 19807797.02 (One Crore Ninety eight lakhs Seven thousand seven hundred ninety seven rupees and Two paisa) Inclusive VAT and PS.

Bidders, submitting their bid electronically, should deposit the non refundable fee of NRs. 3000/- (Three thousands rupees only) of bidding document in **Sanchit Kosh khata** of Bhimad Municipality as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 P.M on 2nd January 2020 A.D (Poush 17, 2076 B.S) at the office of *Bhimad Municipality*. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRs. 500000/-** (Rs. Five Lakhs), which shall be valid for 30 days beyond the validity period of the bid.
