The estimated amount for the works is Rs. (in NRs) 3377341.45 (Exclusive of VAT and Contingencies)

4. Pre-bid meeting shall be held at BHIMAD MUNICIPALITY Nagarpalika chowk Bhimad, Tanahun Gandaki Province Nepal at 24-12-2023 13:00 hours.
5. Sealed or electronic bids must be submitted to the office BHIMAD MUNICIPALITY, Nagarpalika chowk, Bhimad, Tanahun, Gandaki Province, Nepal by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 29-12-2023 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 29-12-2023 13:00 at the office of BHIMAD MUNICIPALITY Nagarpalika chowk Bhimad, Tanahun Gandaki Province Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 100000.0, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
