6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 18-04-2024 13:00 at the office of BHIMAD MUNICIPALITY Nagarpalika chowk Bhimad, Tanahun Gandaki Province Nepal.  
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 25000 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]).
