A complete set of Bidding Documents may be purchased from the office of **Municipal executive, Bhimad Municipality, Bhimad 6 tanahun** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs.3000/- till 2075/11/29** during office hours.
4. Sealed bids must be submitted to the office of **Municipal executive, Bhimad Municipality, Bhimad 6 tanahun** on or before **12:00 noon on 2075/11/30**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend **at 2:00 PM on 2075/11/30** at the office of **Municipal executive, Bhimad Municipality, Bhimad 6 tanahun**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of **Nrs. 60,000/-** which shall be valid for **30 days** beyond the validity period of the bid.
6. If bidder wishes to submit the bid security in form of cash, bidder has to deposit cash in Deposit (**DHARAUTI KHATA**) of Bhimad municipality
