1. **Bhimad Municipality** invites sealed bids from Nepalese eligible bidders for the construction of **Jaupani lift drinking water supply and sanitation project** under National Competitive Bidding procedures. The estimated amount for the works are stated on the table below.

A complete set of Bidding Documents may be purchased from the office of municipal executive, Bhimad Municipality, Bhimad 6 Tanahun by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs.3,000/-** till **2075/12/12** during office hours.
4. Sealed bids must be submitted to the office of **municipal executive, Bhimad Municipality** by hand/courier on or before **12:00 noon** on **2075/12/13**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on date 2075/12/13** at the office of **municipal executive, Bhimad Municipality, Bhimad-6, Tanahun**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of **amount stated on table below** which shall be valid for 30 days beyond the validity period of the bid.
